ARID By-law Article III - Membership

- A. **Voting Members:** A voting member of ARID shall be a member in good standing with RID.
- B. **Non-voting Members:** A non-voting (supporting) member in ARID shall be one who supports ARID, does not wish to have voting privileges and may or may not be a member in good standing with RID.
- C. **Student Members:** A student member in ARID shall be one who supports ARID, is currently registered in an A.A or B.A. Interpreter Education Program (IEP), and one who provides verification in the form a letter of recommendation from their IEP. Student members do not have the right to vote.
